

# Agidor

## For controlling flies in animal housing, agriculture Buildings, and farms.

Agidor contains a mixture of Thiametoxam, which acts as an adulticide to control adult flies, and Tricosene Z-9, an Insect pheromone which attracts the male flies to Agidor.

Agidor unique formulation also contains sugar which increases the products attractiveness and lures flies to come in contact with the product, thus controlling them and preventing them from reproducing.

Agidor is a soluble granule that dissolves in water and can be applied by spraying or smearing.

### Content in 1 Kg:

Active ingredients:

Thiametoxam	10%
Tricosene Z-9 (Pheromone)	0.1%

### Dosage and directions for use:

Spray / smear the area in places where the flies gather or rest. Such as: walls exposed to sunlight, animal cages, garbage containers, feces, food waste, and equipment.

Apply in areas protected from water and inaccessible to children and animals.

#### Spray:

Prepare a solution using 125g of Agidor for each liter of water in room temperature. Mix until homogeneous solution is obtained.

Use one liter of ready for use solution for 20-25 square meter.

The solution should be used immediately after preparation or on the preparation day only. It is recommended to mix the ready for use solution again from time to time.

It is not recommended to spray on dirty surfaces, perforated surfaces or lime – colored surfaces.

#### Smear:

Add 125g of Agidor and mix with 100ml of water in room temperature until receiving a homogeneous solution, possible to smear with a brush.

Smear with a brush 15X20cm spots. 2-3 spots in each 10 square meter.

### Warnings:

1. The product is harmful if swallowed.
2. Avoid breathing dust/fume/gas/mist/vapours/spray.

#### **Safety measures:**

1. In all stages of preparation and application, wear long -sleeved work clothes, use suitable chemical gloves (according to standard EN-374), half -face mask (according to standard EN-140). With an integrated filter (according to standard EN-14387) of the ABEK2 P3 type and goggles (according to standard EN-168).
2. Contact of the solution with skin or eyes should be avoided, as well as its inhaling or swallowing.
3. After application, all body parts which had been exposed to the solution should be thoroughly rinsed and working garments washed separately before reuse.
4. Do not eat, drink or smoke during application.
5. Do not spray directly on feeding or drinking equipment.

#### **Environmental hazards:**

1. The product is very toxic to aquatic life with long lasting effects. Care should be taken not to contaminate water sources while using the product. It should be prevented from reaching fish ponds and water sources.
2. The product is toxic to land dwellers.
3. The product is toxic to bees. Do not spray while there is been activity and near hives. Do not spray on flowering plants that secrete nectar or pollen. It is recommended to spray one hour before sunset and in the evening (not early in the morning), avoid spraying under high wind conditions.

#### **Storage:**

Keep Agidor in its original packing in a locked, cool, dark place, designated for storing chemical products, clear from unauthorized people and away from the reach of children or animals.

#### **Handling of empty containers:**

Rinse the empty packaging thoroughly, at least 3 times. Pour the wash unto the sprayer or to the container used for the application. Pierce the empty package and throw it into the waste container.

#### **First aid and medical advice:**

- 1) In case of inhalation, evacuate the patient to a well-ventilated area and seek medical assistance.
- 2) In case of swallowing, evacuate for medical assistance immediately.
- 3) In case of contact with the skin, rinse with running water and soap, Remove contaminated clothes and shoes.
- 4) In case of eye contact, rinse open eyes with a weak current of clean running water for 15 minutes and seek immediately medical assistance.
